**Win Revenue Summary – February 2004**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$875,956,228 for the month of February 2004. This amounts to a 15.86% increase compared to February 2003, when licensees reported a gaming win of \$756,079,346. For the fiscal year (July 1, 2003 through February 29, 2004), gaming win has increased 3.43%.

### Percentage Fee Collections for the Month of March 2004

The State collected \$75,068,160 in percentage fees during the month of March 2004, based upon the taxable revenues generated in February 2004. This represents a 56.51% (or \$27,105,756) increase compared to the prior year's March (2003), when percentage fee collections were \$47,962,404. During the 20<sup>th</sup> Special Legislative Session percentage fee rates were increased by 8.6%, which should be taken into consideration when making comparisons with the prior fiscal year. The new percentage fee rates became effective in September.

### Fiscal Year 2004 Forecast

Compared to the May 2003 Economic Forum's projections, percentage fee collections for the total of the first nine months of fiscal year 2004 are 3.7% above their forecast. For the current month collections were 35.3% above their forecast. These calculations include the increase in percentage fee rates passed during the 20<sup>th</sup> Special Legislative Session.
