February 2007 Nevada Gaming Revenues and Collections

Win Revenue Summary – February 2007

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,055,714,579 for the month of February 2007. This amounts to a 2.86% <u>increase</u> compared to February 2006, when licensees reported a gaming win of \$1,026,406,625. For the fiscal year (July 1, 2006 through February 28, 2007), gaming win has increased 5.36%.

Percentage Fee Collections for the Month of March 2007

The State collected \$51,623,815 in percentage fees during the month of February 2007, based upon the taxable revenues generated in February 2007. This represents a 26.29% (or \$18,409,485) decrease compared to the prior year's March, when percentage fee collections were \$70,033,300.
