Nevada Gaming Revenues and Collections

Win Revenue Summary – February 2015

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$916,086,085 for the month of February 2015. This amounts to a 1.08% <u>decrease</u> compared to February 2014, when licensees reported a gaming win of \$926,086,897. For the fiscal year (July 1, 2014 through February 28, 2015), gaming win has decreased 1.99%.

Percentage Fee Collections for the Month of March 2015

The State collected \$57,977,938 in percentage fees during the month of March 2015*, based upon the taxable revenues generated in February 2015. This represents a 1.64% (or \$964,326) <u>decrease</u> compared to the prior year's March, when percentage fee collections were \$58,942,264.
