Win Revenue Summary – January 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$866,454,509 for the month of January 2000. This amounts to a 7.32% increase compared to January 1999, when licensees reported a gaming win of \$807,319,974.

Percentage Fee Tax Collections for the Month of February 2000

The State collected \$56,550,732 in percentage fee taxes during the month of February 2000, based upon the taxable revenues generated in January 2000. This represents a 9.65% (or \$4,976,330) increase compared to the prior year's February (1999), when percentage fee collections were \$51,574,402.

On an eight-month fiscal-year-to-date (July 1, 1999 through February 29, 2000), the State of Nevada collected \$365,975,960 in percentage fee taxes. This represents a 14.57% increase from the prior fiscal year eight-month period when collections totaled \$319,424,151.
