**Win Revenue Summary – January 2001**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$896,997,063 for the month of January 2001. This amounts to a 3.52% increase compared to January 2000, when licensees reported a gaming win of \$866,499,250.

**Percentage Fee Tax Collections for the Month of February 2001**

The State collected \$51,421,522 in percentage fee taxes during the month of February 2001, based upon the taxable revenues generated in January 2001. This represents a 9.05% (or \$5,118,294) decrease compared to the prior year's February (2000), when percentage fee collections were \$56,539,816.

On an eight-month fiscal-year-to-date (July 1, 2000 through February 28, 2001), the State of Nevada collected \$357,686,024 in percentage fee taxes. This represents a 2.26% decrease from the prior fiscal year eight-month period when collections totaled \$365,965,044.
