## January 2002 Nevada Gaming Revenues and Collections

## Win Revenue Summary – January 2002

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$766,328,820 for the month of January 2002. This amounts to a 14.83% <u>decrease</u> compared to January 2001, when licensees reported a gaming win of \$899,770,003.

## Percentage Fee Tax Collections for the Month of February 2002

The State collected \$49,905,281 in percentage fee taxes during the month of February 2002, based upon the taxable revenues generated in January 2002. This represents a 2.95% (or \$1,516,241) <u>decrease</u> compared to the prior year's February (2001), when percentage fee collections were \$51,421,522.

On an eight-month fiscal-year-to-date (July 1, 2001 through February 28, 2002), the State of Nevada collected \$345,774,275 in percentage fee taxes. This represents a 3.33% <u>decrease</u> from the prior fiscal year eight-month period when collections totaled \$357,686,024.
