# **Nevada Gaming Revenues and Collections**

### Win Revenue Summary – January 2010

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$883,335,822 for the month of January 2010. This amounts to a 3.22% <u>decrease</u> compared to January 2009, when licensees reported a gaming win of \$912,733,748. For the fiscal year (July 1, 2009 through January 31, 2010), gaming win has decreased 6.61%.

## Percentage Fee Collections for the Month of February 2010

The State collected \$59,659,546 in percentage fees during the month of February 2010, based upon the taxable revenues generated in January 2010. This represents a 26.79% (or \$12,607,160) <u>increase</u> compared to the prior year's February, when percentage fee collections were \$47,052,386.
