Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2016

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$925,316,080 for the month of January 2016. This amounts to a 2.87% <u>decrease</u> compared to January 2015, when licensees reported a gaming win of \$952,665,050. For the fiscal year (July 1, 2015 through January 31, 2016), gaming win has increased 0.59%.

Percentage Fee Collections for the Month of February 2016

The State collected \$81,737,166 in percentage fees during the month of February 2016*, based upon the taxable revenues generated in January 2016. This represents a 19.59% (or \$13,386,803) <u>increase</u> compared to the prior year's February, when percentage fee collections were \$68,350,363.
