Win Revenue Summary - January 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$807,150,964 for the month of January 1999. This amounts to a 16.63% increase compared to January 1998, when licensees reported a gaming win of \$692,057,545.

Percentage Fee Tax Collections for the Month of February 1999

The State collected \$51,577,564 in percentage fee taxes during the month of February 1999, based upon the taxable revenues generated in January 1999. This represents a 26.18% (or \$10,702,040) increase compared to the prior year's February (1998), when percentage fee collections were \$40,875,524.

On an eight-month fiscal-year-to-date (July 1, 1998 through February 28, 1999), the State of Nevada collected \$319,427,313 in percentage fee taxes. This represents a 11.31% increase from the prior fiscal year eight-month period when collections totaled \$286,973,037.
