# July 2001 Nevada Gaming Revenues and Collections

### Win Revenue Summary – July 2001

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$808,294,634 for the month of July 2001. This amounts to a 2.34% decrease compared to July 2000, when licensees reported a gaming win of \$827,662,827.

## Percentage Fee Tax Collections for the Month of August 2001

The State collected \$54,064,115 in percentage fee taxes during the month of August 2001, based upon the taxable revenues generated in July 2001. This represents a 10.79% (or \$5,265,022) increase compared to the prior year's August (2000), when percentage fee collections were \$48,799,093.

On a two-month fiscal-year-to-date (July 1, 2001 through August 31, 2001), the State of Nevada collected \$92,120,368 in percentage fee taxes. This represents a 3.42% <u>increase</u> from the prior fiscal year two-month period when collections totaled \$89,075,290.
