July 2002 Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2002

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$804,310,815 for the month of July 2002. This amounts to a 0.51% <u>decrease</u> compared to July 2001, when licensees reported a gaming win of \$808,422,287.

Percentage Fee Tax Collections for the Month of August 2002

The State collected \$47,895,274 in percentage fee taxes during the month of August 2002, based upon the taxable revenues generated in July 2002. This represents an 11.41% (or \$6,168,841) <u>decrease</u> compared to the prior year's August (2001), when percentage fee collections were \$54,064,115.

On a two-month fiscal-year-to-date (July 1, 2002 through August 31, 2002), the State of Nevada collected \$85,394,578 in percentage fee taxes. This represents a 7.30% <u>decrease</u> from the prior fiscal year two-month period when collections totaled \$92,120,368.
