Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2007

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,146,006,059 for the month of July 2007. This amounts to a 10.25% <u>increase</u> compared to July 2006, when licensees reported a gaming win of \$1,039,448,158.

Percentage Fee Collections for the Month of August 2007

The State collected \$76,568,354 in percentage fees during the month of August 2007, based upon the taxable revenues generated in July 2007. This represents a 16.99% (or \$11,120,154) <u>increase</u> compared to the prior year's August, when percentage fee collections were \$65,448,200.
