Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2011

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$860,089,795 for the month of July 2011. This amounts to a 3.66% increase compared to July 2010, when licensees reported a gaming win of \$829,682,912.

Percentage Fee Collections for the Month of August 2011

The State collected \$48,078,178 in percentage fees during the month of August 2011, based upon the taxable revenues generated in July 2011. This represents a 3.56% (or \$1,775,364) decrease compared to the prior year's August, when percentage fee collections were \$49,853,542.
