Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,005,876,336 for the month of July 2012. This amounts to a 16.95% increase compared to July 2011, when licensees reported a gaming win of \$860,076,138.

Percentage Fee Collections for the Month of August 2012

The State collected \$67,521,797 in percentage fees during the month of August 2012, based upon the taxable revenues generated in July 2012. This represents a 40.45% (or \$19,445,380) increase compared to the prior year's August, when percentage fee collections were \$48,076,417.
