Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2016

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,015,014,676 for the month of July 2016. This amounts to a 9.96% <u>increase</u> compared to July 2015, when licensees reported a gaming win of \$923,035,888.

Percentage Fee Collections for the Month of August 2016

The State collected \$68,281,548 in percentage fees during the month of August 2016*, based upon the taxable revenues generated in July 2016. This represents a 19.87% (or \$11,320,500) <u>increase</u> compared to the prior year's August, when percentage fee collections were \$56,961,048.
