Percentage Fee Collections for the Month of August 2017

The State collected \$69,150,680 in percentage fees during the month of August 2017*, based upon the taxable revenues generated in July 2017. This represents a 1.08% (or \$738,816) increase compared to the prior year's August, when percentage fee collections were \$68,411,864.
