Win Revenue Summary – July 2018

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of **996,439,793** for the month of July 2018. This amounts to a **0.16% decrease** compared to July 2017, when licensees reported a gaming win of **\$997,994,304**.

Percentage Fee Collections for the Month of August 2018

The State collected \$55,805,243 in percentage fees during the month of August 2018*, based upon the taxable revenues generated in July 2018. This represents a 19.30% (or \$13,348,232) decrease compared to the prior year's August, when percentage fee collections were \$69,153,475.
