Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2020

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$756,793,269 for the month of July 2020. This amounts to a 26.16% decrease compared to July 2019, when licensees reported a gaming win of \$1,024,925,615.

Percentage Fee Collections for the Month of August 2020

The State collected \$32,282,165 in percentage fees during the month of August 2020*, based upon the taxable revenues generated in July 2020. This represents a 56.33% (or \$41,637,748) decrease compared to the prior year's August, when percentage fee collections were \$73,919,913.
