Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,359,876,493 for the month of July 2021. This amounts to a 79.69% <u>increase</u> compared to July 2020, when licensees reported a gaming win of \$756,772,679.

Percentage Fee Collections for the Month of August 2021

The State collected \$97,701,941 in percentage fees during the month of August 2021*, based upon the taxable revenues generated in July 2021. This represents a 202.02% (or \$65,352,836) increase compared to the prior year's August, when percentage fee collections were \$32,349,105.
