Win Revenue Summary - July 1998

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$700,139,237 for the month of July 1998. This amounts to a 4.31% increase compared to July 1997, when licensees reported a gaming win of \$671,217,004.

**Percentage Fee Tax Collections for the Month of August 1998**

The State collected \$42,379,736 in percentage fee taxes during the month of August 1998, based upon the taxable revenues generated in July 1998. This represents a 2.77% (or \$1,141,496) increase compared to the prior year's August (1998), when percentage fee collections were \$41,238,240.

On a two-month fiscal-year-to-date (July 1, 1998 through August 31, 1998), the State of Nevada collected \$77,502,626 in percentage fee taxes. This represents a 11.67% increase from the prior fiscal year two-month period when collections totaled \$69,403,236.
