Win Revenue Summary - June 2000

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$747,838,455 for the month of June 2000. This amounts to an 8.01% increase compared to June 1999, when licensees reported a gaming win of \$692,402,738.

Percentage Fee Tax Collections for the Month of July 2000

The State collected \$40,277,545 in percentage fee taxes during the month of July 2000, based upon the taxable revenues generated in June 2000. This represents a 2.36% (or \$928,168) increase compared to the prior year's July (1999), when percentage fee collections were \$39,349,377.
