Win Revenue Summary – June 2002

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$714,149,806 for the month of June 2002. This amounts to a 7.96% decrease compared to June 2001, when licensees reported a gaming win of \$775,954,386.

Percentage Fee Tax Collections for the Month of July 2002

The State collected \$37,499,304 in percentage fee taxes during the month of July 2002, based upon the taxable revenues generated in June 2002. This represents a 1.46% (or \$556,949) decrease compared to the prior year's July (2001), when percentage fee collections were \$38,056,253.
