Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2003

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$809,187,341 for the month of June 2003. This amounts to a 13.28% <u>increase</u> compared to June 2002, when licensees reported a gaming win of \$714,352,042.

Percentage Fee Tax Collections for the Month of July 2003

The State collected \$44,523,508 in percentage fee taxes during the month of July 2003, based upon the taxable revenues generated in June 2003. This represents an 18.73% (or \$7,024,204) <u>increase</u> compared to the prior year's July (2002), when percentage fee collections were \$37,499,304.
