## June 2004 Nevada Gaming Revenues and Collections

### Win Revenue Summary – June 2003

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$855,461,777 for the month of June 2004. This amounts to a 5.73% <u>increase</u> compared to June 2003, when licensees reported a gaming win of \$809,104,923. For the fiscal year (July 1, 2003 through June 30, 2004), gaming win has increased 5.71%.

### Percentage Fee Collections for the Month of July 2004

The State collected \$54,436,245 in percentage fees during the month of July 2004, based upon the taxable revenues generated in June 2004. This represents a 22.26% (or \$9,912,735) increase compared to the prior year's July (2003), when percentage fee collections were \$44,523,510. During the 20<sup>th</sup> Special Legislative Session percentage fee rates were increased by 8.6%, which should be taken into consideration when making comparisons with the prior fiscal year. The new percentage fee rates became effective in September.
