June 2006 Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2006

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$921,077,156 for the month of June 2006. This amounts to a 3.47% <u>decrease</u> compared to June 2005, when licensees reported a gaming win of \$954,172,371. For the fiscal year (July 1, 2005 through June 30, 2006), gaming win increased 10.80%.

Percentage Fee Collections for the Month of July 2006

The State collected \$55,105,122 in percentage fees during the month of July 2006, based upon the taxable revenues generated in June 2006. This represents a 1.01% (or \$549,460) increase compared to the prior year's July, when percentage fee collections were \$54,555,662.
