Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2009

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$818,180,981 for the month of June 2009. This amounts to a 13.82% <u>decrease</u> compared to June 2008, when licensees reported a gaming win of \$949,332,178. For the fiscal year (July 1, 2008 through June 30, 2009), gaming win has decreased 13.72%.

Percentage Fee Collections for the Month of July 2009

The State collected \$45,680,446 in percentage fees during the month of July 2009, based upon the taxable revenues generated in June 2009. This represents a 13.48% (or \$7,119,878) <u>decrease</u> compared to the prior year's June, when percentage fee collections were \$52,800,324.
