Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2012

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$832,518,772 for the month of June 2012. This amounts to a 6.01% <u>decrease</u> compared to June 2011, when licensees reported a gaming win of \$885,763,549. For the fiscal year (July 1, 2011 through June 30, 2012), gaming win has increased 0.66%.

Percentage Fee Collections for the Month of July 2012

The State collected \$38,280,703 in percentage fees during the month of July 2012, based upon the taxable revenues generated in June 2012. This represents a 27.47% (or \$14,499,867) decrease compared to the prior year's July, when percentage fee collections were \$52,780,570.
