Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2019

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,040,994,041 for the month of June 2019. This amounts to an 11.57% <u>increase</u> compared to June 2018, when licensees reported a gaming win of \$933,019,638. For the fiscal year (July 1, 2018 through June 30, 2019), gaming win has increased 0.80%.

Percentage Fee Collections for the Month of July 2019

The State collected \$55,050,705 in percentage fees during the month of July 2019*, based upon the taxable revenues generated in June 2019. This represents a 15.91% (or \$7,558,194) increase compared to the prior year's July, when percentage fee collections were \$47,492,511.
