Win Revenue Summary - June 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$692,399,243 for the month of June 1999. This amounts to a 11.03% increase compared to June 1998, when licensees reported a gaming win of \$623,594,754.

Percentage Fee Tax Collections for the Month of July 1999

The State collected \$39,345,580 in percentage fee taxes during the month of July 1999, based upon the taxable revenues generated in June 1999. This represents a 12.02% (or \$4,222,690) increase compared to the prior year's July (1998), when percentage fee collections were \$35,122,890.
