Win Revenue Summary – March 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$836,453,390 for the month of March 2000. This amounts to an 11.91% increase compared to March 1999, when licensees reported a gaming win of \$747,449,239.

Percentage Fee Tax Collections for the Month of April 2000

The State collected \$64,633,870 in percentage fee taxes during the month of April 2000, based upon the taxable revenues generated in March 2000. This represents a 15.59% (or \$8,719,101) increase compared to the prior year's April (1999), when percentage fee collections were \$55,914,769.

On a ten-month fiscal-year-to-date (July 1, 1999 through April 30, 2000), the State of Nevada collected \$470,876,068 in percentage fee taxes. This represents a 14.50% increase from the prior fiscal year ten-month period when collections totaled \$411,261,025.
