Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2005

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,031,855,451 for the month of March 2005. This amounts to a 10.91% <u>increase</u> compared to March 2004, when licensees reported a gaming win of \$930,336,296. For the fiscal year (July 1, 2004 through March 31, 2005), gaming win has increased 8.25%.

Percentage Fee Collections for the Month of April 2005

The State collected \$88,630,001 in percentage fees during the month of April 2005, based upon the taxable revenues generated in March 2005. This represents an 8.54% (or \$6,973,148) <u>increase</u> compared to the prior year's April (2004), when percentage fee collections were \$81,656,853.
