March 2007 Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2007

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,054,767,039 for the month of March 2007. This amounts to a 0.79% <u>decrease</u> compared to March 2006, when licensees reported a gaming win of \$1,063,165,011. For the fiscal year (July 1, 2006 through March 31, 2007), gaming win has increased 4.64%.

Percentage Fee Collections for the Month of April 2007

The State collected \$92,055,994 in percentage fees during the month of April 2007, based upon the taxable revenues generated in March 2007. This represents a 0.77% (or \$711,207) decrease compared to the prior year's April, when percentage fee collections were \$92,767,201.
