March 2016 Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2016

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$922,272,002 for the month of March 2016. This amounts to a 3.04% <u>decrease</u> compared to March 2015, when licensees reported a gaming win of \$951,187,038. For the fiscal year (July 1, 2015 through March 31, 2016), gaming win has increased 1.00%.

Percentage Fee Collections for the Month of April 2016

The State collected \$72,941,860 in percentage fees during the month of April 2016*, based upon the taxable revenues generated in March 2016. This represents an 8.09% (or \$6,421,215) decrease compared to the prior year's April, when percentage fee collections were \$79,363,075.
