March 1998 Nevada Gaming Revenues and Collections

Win Revenue Summary - March 1998

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$673,149,083 for the month of March 1998. This amounts to a 6.78% <u>increase</u> compared to March 1997, when licensees reported a gaming win of \$630,394,295.

Percentage Fee Tax Collections for the Month of April 1998

The State collected \$56,369,751 in percentage fee taxes during the month of April 1998, based upon the taxable revenues generated in March 1998. This represents a 14.00% (or \$6,923,158) <u>increase</u> compared to the prior year's April (1997), when percentage fee collections were \$49,446,603.

On a ten-month fiscal-year-to-date (July 1, 1997 through April 30, 1998) basis, the State of Nevada collected \$379,473,606 in percentage fee taxes. This represents a 3.59% <u>increase</u> from the prior fiscal year ten-month period when collections totaled \$366,314,639.
