May 2001 Nevada Gaming Revenues and Collections

Win Revenue Summary - May 2001

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$844,231,932 for the month of May 2001. This amounts to a 5.66% increase compared to May 2000, when licensees reported a gaming win of \$799,033,733.

Percentage Fee Tax Collections for the Month of June 2001

The State collected \$56,231,443 in percentage fee taxes during the month of June 2001, based upon the taxable revenues generated in May 2001. This represents a 7.88% (or \$4,108,866) increase compared to the prior year's June (2000), when percentage fee collections were \$52,122,577.

On a twelve-month fiscal-year-to-date (July 1, 2000 through June 30, 2001), the State of Nevada collected \$565,018,812 in percentage fee taxes. This represents a .85% <u>increase</u> from the prior fiscal year twelve-month period when collections totaled \$560,236,663.
