May 2005 Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2005

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,023,996,523 for the month of May 2005. This amounts to a 12.50% <u>increase</u> compared to May 2004, when licensees reported a gaming win of \$910,202,957. For the fiscal year (July 1, 2004 through May 31, 2005), gaming win has increased 8.48%.

Percentage Fee Collections for the Month of June 2005

The State collected \$72,947,857 in percentage fees during the month of June 2005, based upon the taxable revenues generated in May 2005. This represents an 32.80% (or \$18,017,765) increase compared to the prior year's June (2004), when percentage fee collections were \$54,930,092.
