May 2007 Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2007

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,143,678,866 for the month of May 2007. This amounts to a 1.52% <u>increase</u> compared to May 2006, when licensees reported a gaming win of \$1,126,548,839. For the fiscal year (July 1, 2006 through May 31, 2007), gaming win has increased 4.49%.

Percentage Fee Collections for the Month of June 2007

The State collected \$83,313,220 in percentage fees during the month of June 2007, based upon the taxable revenues generated in May 2007. This represents a 16.39% (or \$11,735,017) increase compared to the prior year's June, when percentage fee collections were \$71,578,203.
