Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2009

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$889,092,564 for the month of May 2009. This amounts to an 8.34% <u>decrease</u> compared to May 2008, when licensees reported a gaming win of \$970,003,519. For the fiscal year (July 1, 2008 through May 31, 2009), gaming win has decreased 13.71%.

Percentage Fee Collections for the Month of June 2009

The State collected \$50,844,403 in percentage fees during the month of June 2009, based upon the taxable revenues generated in May 2009. This represents a 19.89% (or \$12,623,297) <u>decrease</u> compared to the prior year's June, when percentage fee collections were \$63,467,700.
