Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2012

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$885,086,463 for the month of May 2012. This amounts to a 10.05% <u>decrease</u> compared to May 2011, when licensees reported a gaming win of \$984,006,380. For the fiscal year (July 1, 2011 through May 31, 2012), gaming win has increased 1.26%.

Percentage Fee Collections for the Month of June 2012

The State collected \$51,940,389 in percentage fees during the month of June 2012, based upon the taxable revenues generated in May 2012. This represents a 24.14% (or \$16,524,988) <u>decrease</u> compared to the prior year's June, when percentage fee collections were \$68,465,377.
