## Win Revenue Summary - May 2017

Nevada's nonrestricted gaming licensees reported a total "gaming win" of $\$ 991,604,782$ for the month of May 2017. This amounts to a $3.51 \%$ increase compared to May 2016, when licensees reported a gaming win of $\$ 957,937,998$. For the fiscal year (July 1, 2016 through May 31, 2017), gaming win has increased $3.08 \%$.

## Percentage Fee Collections for the Month of June 2017

The State collected $\mathbf{\$ 5 2 , 3 1 4 , 6 3 1}$ in percentage fees during the month of June $2017^{*}$, based upon the taxable revenues generated in May 2017. This represents a $\mathbf{2 . 6 2 \%}$ (or $\$ 1,337,022$ ) increase compared to the prior year's June, when percentage fee collections were $\mathbf{\$ 5 0 , 9 7 7 , 6 0 9}$.
