Win Revenue Summary - May 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$758,562,203 for the month of May 1999. This amounts to a 9.86% <u>increase</u> compared to May 1998, when licensees reported a gaming win of \$690,502,787.

Percentage Fee Tax Collections for the Month of June 1999

The State collected \$48,429,907 in percentage fee taxes during the month of June 1999, based upon the taxable revenues generated in May 1999. This represents a 3.14% (or \$1,476,644) increase compared to the prior year's June (1998), when percentage fee collections were \$46,953,263.

On a fiscal year (July 1, 1998 through June 30, 1999) basis, the State of Nevada collected \$496,505,396 in percentage fee taxes. This represents an 8.12% <u>increase</u> from the prior fiscal year period when collections totaled \$459,206,054.
