Win Revenue Summary – November 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$721,492,771 for the month of November 2001. This amounts to a 7.45% decrease compared to November 2000, when licensees reported a gaming win of \$779,584,065.

Percentage Fee Tax Collections for the Month of December 2001

The State collected \$37,493,735 in percentage fee taxes during the month of December 2001, based upon the taxable revenues generated in November 2001. This represents a 9.35% (or \$3,868,516) decrease compared to the prior year's December (2000), when percentage fee collections were \$41,362,251.

On a six-month fiscal-year-to-date (July 1, 2001 through December 31, 2001), the State of Nevada collected \$264,405,393 in percentage fee taxes. This represents a 4.23% decrease from the prior fiscal year six-month period when collections totaled \$276,082,461.
