November 2006 Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2006

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,140,738,141 for the month of November 2006. This amounts to a 14.11% <u>increase</u> compared to November 2005, when licensees reported a gaming win of \$999,643,489. For the fiscal year (July 1, 2006 through November 30, 2006), gaming win has increased 5.45%.

Percentage Fee Collections for the Month of December 2006

The State collected \$75,324,614 in percentage fees during the month of December 2006, based upon the taxable revenues generated in November 2006. This represents a 19.01% (or \$12,029,667) <u>increase</u> compared to the prior year's November, when percentage fee collections were \$63,294,947.
