Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2008

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$836,787,265 for the month of November 2008. This amounts to a 14.80% <u>decrease</u> compared to November 2007, when licensees reported a gaming win of \$982,108,428. For the fiscal year (July 1, 2008 through November 30, 2008), gaming win has decreased 12.93%.

Percentage Fee Collections for the Month of December 2008

The State collected \$44,445,929 in percentage fees during the month of December 2008, based upon the taxable revenues generated in November 2008. This represents a 27.05% (or \$16,480,614) <u>decrease</u> compared to the prior year's December, when percentage fee collections were \$60,926,543.
