Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2009

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$873,178,311 for the month of November 2009. This amounts to a 4.35% <u>increase</u> compared to November 2008, when licensees reported a gaming win of \$836,817,999. For the fiscal year (July 1, 2009 through November 30, 2009), gaming win has decreased 7.91%.

Percentage Fee Collections for the Month of December 2009

The State collected \$57,029,541 in percentage fees during the month of December 2009, based upon the taxable revenues generated in November 2009. This represents a 28.31% (or \$12,583,612) <u>increase</u> compared to the prior year's December, when percentage fee collections were \$44,445,929.
