Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2014

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$876,278,690 for the month of November 2014. This amounts to a 0.04% <u>increase</u> compared to November 2013, when licensees reported a gaming win of \$875,941,506. For the fiscal year (July 1, 2014 through November 30, 2014), gaming win has decreased 2.67%.

Percentage Fee Collections for the Month of December 2014

The State collected \$47,432,853 in percentage fees during the month of December 2014*, based upon the taxable revenues generated in November 2014. This represents a 5.16% (or \$2,579,467) <u>decrease</u> compared to the prior year's December, when percentage fee collections were \$50,012,320.
