## **Nevada Gaming Revenues and Collections**

# Win Revenue Summary – November 2020

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$771,162,743 for the month of November 2020. This amounts to a 17.75% <u>decrease</u> compared to November 2019, when licensees reported a gaming win of \$937,533,406. For the fiscal year (July 1, 2020 through November 30, 2020), gaming win has decreased 21.64%.

# Percentage Fee Collections for the Month of December 2020

The State collected \$49,875,540 in percentage fees during the month of December 2020\*, based upon the taxable revenues generated in November 2020. This represents a 16.02% (or \$9,516,252) <u>decrease</u> compared to the prior year's December, when percentage fee collections were \$59,391,792.
