Win Revenue Summary - November 1997

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$622,611,837 for the month of November 1997. This amounts to a 8.94% <u>increase</u> compared to November 1996, when licensees reported a gaming win of \$571,543,841.

Percentage Fee Tax Collections for the Month of December 1997

The State collected \$31,495,164 in percentage fee taxes during the month of December 1997, based upon the taxable revenues generated in November 1997. This represents a 6.72% (or \$2,269,959) <u>decrease</u> compared to the prior year's December (1996), when percentage fee collections were \$33,765,123.

On a six-month fiscal-year-to-date (July 1, 1997 through December 31, 1997), the State of Nevada collected \$219,171,364 in percentage fee taxes. This represents a 0.48% <u>increase</u> from the prior fiscal year six-month period when collections totaled \$218,127,533.
