**Win Revenue Summary – November 1999**

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$804,800,105 for the month of November 1999. This amounts to a 21.67% increase compared to November 1998, when licensees reported a gaming win of \$661,462,453.

**Percentage Fee Tax Collections for the Month of December 1999**

The State collected \$48,498,599 in percentage fee taxes during the month of December 1999, based upon the taxable revenues generated in November 1999. This represents a 23.14% (or \$9,114,839) increase compared to the prior year's December (1998), when percentage fee collections were \$39,383,760.

On a six-month fiscal-year-to-date (July 1, 1999 through December 31, 1999), the State of Nevada collected \$274,809,628 in percentage fee taxes. This represents a 16.34% increase from the prior fiscal year six-month period when collections totaled \$236,207,442.
