**Win Revenue Summary – October 2000**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$811,265,633 for the month of October 2000. This amounts to a 1.98% increase compared to October 1999, when licensees reported a gaming win of \$795,496,865.

**Percentage Fee Tax Collections for the Month of November 2000**

The State collected \$48,226,120 in percentage fee taxes during the month of November 2000, based upon the taxable revenues generated in October 2000. This represents a -2.12% (or -\$1,042,209) decrease compared to the prior year's November (1999), when percentage fee collections were \$49,268,329.

On a five-month fiscal-year-to-date (July 1, 2000 through November 30, 2000), the State of Nevada collected \$234,720,210 in percentage fee taxes. This represents a 3.72% increase from the prior fiscal year five-month period when collections totaled \$226,311,029.
